Bakeries impacted by OSHA National Emphasis Program

OSHA recently posted a new directive to its website containing policies and procedures for inspecting workplaces that create or handle combustible dust. The NEP can be found at: http://www.osha.gov/OshDoc/Directive_pdf/ CPL_03-00-006.pdf.

Upon further review, bakeries are impacted in this OSHA NEP since flour dust is classified as Class II Group G (see pages 4-5). It appears that OSHA will be focusing on housekeeping issues (see page 16).

In fact, a record number of TIA members attended the educational seminars and also filled out surveys. 
May 12th – 15th 2008 in Phoenix AZ TIA Spring Educational & Technical Conference
